**GARDEN HILLS DIVE TEAM  
AUTHORIZATION FOR PARTICIPATION  
AND RELEASE OF LIABILITY**

In consideration of my child being allowed to participate on the Garden Hills Dive Team, including but not limited to all meets, practices and activities, I acknowledge, consent and agree to the following:

1) There is risk of serious injury, including permanent disability and even death, to the Diver, from the activities associated with participation on the Garden Hills Dive Team, and while rules, equipment and personal discipline may reduce the risk, the risk of serious injury to the Diver does exist and can never be eliminated;

2) On behalf of the Diver, myself and spouse, I KNOWINGLY, FREELY AND VOLUNTARILY ASSUME ALL SUCH RISKS, both known and unknown, and seen and unforeseen, EVEN IF ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERS, and assume full responsibility for the participation of Diver on the Garden Hills Dive Team;

3) On behalf of Diver, I willingly agree to comply with all rules, regulations and guidelines of the Garden Hills Dive Team, The Greater Atlanta Diving League and all facilities. If I observe any conditions affecting the safety of the Diver or have any concern in the readiness of the Diver for participation in any activity or event as a member of the Garden Hills Dive Team, I will remove the Diver from participation and immediately notify the nearest official and Garden Hills Dive Team coach;

4) On behalf of Diver, myself and my spouse, including our heirs, legal guardians, personal representatives and next of kin, I KNOWINGLY, FREELY AND VOLUNTARILY RELEASE GARDEN HILLS POOL AND PARK ASSOCIATION, its board members, directors, officers, agents and employees, other participants, sponsoring agencies, and facility owners (hereinafter "RELEASEES"), WITH RESPECT TO ANY AND ALL INJURY, DISABILITY, DEATH, or loss or damage to person or property incident to Diver's involvement or participation on the Garden Hills Dive Team, WHETHER ARISING FROM THE NEGLIGENCE OF RELEASEES OR OTHERWISE, to the fullest extent permitted by law.

5) On behalf of Diver, myself, my spouse, including our heirs, legal guardians, personal representatives and next of kin, I KNOWINGLY, FREELY AND VOLUNTARILY AGREE TO INDEMNIFY AND HOLD HARMLESS ALL THE ABOVE Releasees from any and all liabilities incident to Diver's involvement or participation on the Garden Hills Dive Team, EVEN IF ARISING FROM THEIR NEGLIGENCE, to the fullest extent permitted by law.
